MESSAGE FROM THE PRESIDENT

The year 2022 witnessed challenging times for Ghana, so far as safe use of internet is concerned, specially by school children(Child Online Protection) and youth. It, however, gives a great sense of satisfaction that GISF responded well to all those emerging challenges posed by the ill-impacts of unsupervised usage of internet by these target groups.

The widely reported news of eight(8) Senior High School students who were dismissed from school for openly insulting the President of Ghana which directly contradict the rules and regulations of student conduct in the Ghana Educational System. The increase in pornography addiction, online gambling and online sexual grooming among school children and youth was also well circulated in the local Ghanaian media.

Despite these and many more worrisome incidents, we were able to make positive gains in our advocacy and awareness programs and also provide some interventional programs in Child Online Protection cases.

The Annual Report 2022 covers in detail - all our programs and activities that were successfully undertaken during the year under report, I am delighted to briefly mention a few of them, as a quick reference for you and our readers.

As in past years, GISF in collaboration with Meta (Facebook) celebrated the Safer Internet Day on 8th Februay 2022. GISF engaged some selected schools in Ashanti Region, numbering about 600 students and their teachers who significantly benefited from basic digital literacy by utilizing our online safety educational materials.

We are extremely grateful to the Microsoft Corporation that they supported us by providing necessary support via their Employee Giving Program to conduct two very important programs in this year, viz. viz. Stakeholders' Conference on Child Online Protection 2022 (held during March 2022) and Cybersafety Ambassadors Program (held during May 2022).

These events were held for several schools in Ghana with a view to create awareness about Child Online Protection, cyber-bullying, sextortion and interventional measures on how to stop this menace.

The next important collaborative initiative of GISF was the 1st ever National Digital Parenting Conference, which was supported by the Digital Aid International, and its specific theme was 'Protecting Your Family Online: 10 Things Every Parent Should Know'. The event encouraged parents and guardians to have close connection with their children and urged them to initiate conversations with their children about their online activities.

I also wish to mention a few of the major challenges that we have been facing during the period of our program execution. Unavailability or inadequate funds has been the major challenge for us, in that it limits the impact scope of our progams and activities. Most Governments in Africa have traditionally not valued the socioeconomic impact of cybersecurity on the growth of their economies and thus have applied limited resources to addressing its negative impact. Including Ghana, approximately 15% of the countries in Africa have a clear legal framework in place, which criminalise online behaviours that facilitate offline crimes. GISF also intends to seek international cooperations and partnerships as well, to promote safer online activities in Africa. The Foundation looks forward to apply and seek support and grants in order to conduct all these initiatives and activities in an efficient manner.

On behalf of GISF and myself, we are sincerely grateful to all our collaborative partners who helped us with their financial, counsel and other resources to conduct all the programs and activities of the Foundation smoothly. I also extend profound thanks to all our board & team members, officials & staff, volunteers and other stakeholders, who worked for GISF and contributed to all the Foundation's activities.

According to a UNICEF report (Children's Online Practices in Ghana, 2017), about 8 in 10 children visit Facebook, 5 in 10 visits WhatsApp and 2 in 10 visit YouTube. For the top three visited social networking sites/platforms, more boys and urban residents visit the sites most. 3 in 10 children have experienced something that bothered them online. 4 in 10 children will accept all requests made to them online. 2 in 10 children have met someone in person who they first got to know online. Only 1 in 10 children sends a photo or video of themselves to someone they have not met face to face, and 2 in 10 children have been treated in a harmful way or in a way they did not like while online. The report also states that about 2 in 10 parents/guardians never check what their children are doing on the internet.
